

OpenCL Logo License Agreement

This OpenCL License Agreement (“License”) is entered into by and between Apple Inc., 1 Infinite Loop, Cupertino, California 95014, USA (“Apple”) and the company listed below (“Licensee”) and is effective as of the date Apple confirms approval of this Agreement (“Effective Date”).

1. The OpenCL trademark and logo are trademarks owned solely and exclusively by Apple and have been licensed to the Khronos Group in connection with the development and implementation of the OpenCL standard.
2. Apple grants Licensee a limited, non-exclusive, non-transferable, royalty-free, worldwide license to use Apple’s OpenCL logo artwork (the “Artwork”) in connection with products that are compatible with the OpenCL standard developed by the Khronos Group (the “Product”) subject to the terms set out below and the OpenCL Logo Guidelines, found at <http://developer.apple.com/softwarelicensing/agreements/opencl> which may be amended from time to time.
3. Apple or the Khronos Group (<http://www.khronos.org>) may list the name of Licensee’s company (or Licensee’s name, if an individual) in an index of Products that include OpenCL technology.
4. Apple shall remain the exclusive owner of all rights to the Artwork. Licensee’s use of the Artwork shall inure to the benefit of Apple exclusively. Licensee agrees it has no rights in the Artwork except for those extent granted by this License. Licensee agrees that this License does not grant any rights with respect to any other Apple trademarks, including the OpenCL word mark.

5. Licensee will not do anything inconsistent with Apple's ownership of the Artwork, the OpenCL trademark or logo, or any other Apple trademark, or similarly affect the value or the goodwill pertaining thereto. Licensee agrees not to use the Logo or any other Apple trademark in any manner that suggests Apple's endorsement, sponsorship, or recommendation of Licensee's Product, or otherwise creates a false association with Apple.
6. Upon Apple's request, Licensee shall supply Apple, at no cost and with no obligation to return, suitable specimens of its use of the Artwork to verify Licensee's compliance with this License.
7. THE ARTWORK IS PROVIDED TO LICENSEE ON AN "AS IS" BASIS. APPLE DISCLAIMS ALL WARRANTIES REGARDING THE ARTWORK, INCLUDING WARRANTIES AGAINST INFRINGEMENTS OF THIRD PARTY RIGHTS AND ANY WARRANTIES THAT MAY BE IMPLIED BY LAW. APPLE SHALL NOT BE LIABLE FOR ANY DAMAGES ARISING FROM OR RELATED TO LICENSEE'S USE OF THE ARTWORK OR TERMINATION OF THIS AGREEMENT.
8. Licensee will defend, indemnify, and hold harmless Apple against all losses, liability, damage, cost, and/or expense (include reasonable legal fees) arising out of any claims or suits, whatever their nature and however arising, which may be brought or made against Apple because of Licensee's use of the Artwork in any manner except as expressly permitted by this License, or for any personal injury, product liability or other claim arising from the manufacture, promotion, distribution, sale, and/or offer for sale, and/or the performance of Licensee's Product.
9. This License is revocable at will by Apple. However, in the event this License is revoked, Licensee will be given thirty (30) days to remove Artwork from materials and web sites, provided such use is in compliance with the terms of this License and the OpenCL Logo Guidelines.
10. This License shall be governed by the laws of the State of California without regard to, or application of, choice of law rules or principles, and controlling U.S. federal law. Any proceedings arising out of this License shall take place in the United States District Court for the Northern District of California or the California Superior Court for the County of Santa Clara. If any provision of this License is held by a court of competent jurisdiction to be contrary to law, that provision will be enforced to the maximum extent permissible, and the remaining provisions of this License will remain in full force and effect.
11. The terms of this License constitute the entire agreement between Licensee and Apple concerning the Artwork. Any waiver or amendment of any part of this License is effective only if in writing and signed by an authorized representative of both Licensee and Apple. Any proposals for additional or different terms are hereby rejected.
